PRODUCT DESCRIPTION

GPS-9772 is a two component, 100% solids, fast set, rigid aromatic hybrid polyurea/polyurethane spray for spray in mold applications requiring excellent impact resistance and durability. Typical applications include replication of rocks, stone panels, decorative boulders, sea corals, architectural trim, automobile aftermarket panels, wood and many more molded applications. GPS-9772 is also ideal for adding a plastic-like encapsulation shell for delicate foams and expanded polystyrene. Plus, GPS-2272 offers excellent flow to wet out molds for superior surface replication and appearance.

PACKAGING, STORAGE AND SHELF LIFE

100 gallon kit: One 50 gallon drum of Part-A and one 50 gallon drum of Part-B. Avoid freezing temperatures. GPS-9772 has a shelf life of nine (9) months from date of manufacture in factory sealed containers.

Part-A and Part-B drums must be stored above 50°F (10°C). Avoid freezing temperatures. Store drums on wooden pallets to avoid direct contact with the ground. If stored for a long period of time, rotate Part-A and Part-B drums regularly.

SAFETY PRECAUTIONS

GPS-9772 IS FOR INDUSTRIAL USE ONLY. Avoid contact with eyes, and skin; do not inhale or ingest. When working with this material wear goggles, rubber gloves and a respirator. When spraying in a confined area, also wear a fresh air hood and make provision for forced ventilation. Refer to MSDS regarding individual components. This product contains Isocyanates and Curative Material.

MIXING

GPS-9772 may not be diluted under any circumstances. Thoroughly mix GPS-9772 Part-B Base material with air driven power equipment until a homogeneous mixture and color is obtained or use recirculation.

APPLICATION PROCEDURES

Remove all contaminant, oil and grease from substrate. For all molds, do a test patch with mold release to confirm the part will release before conditioning the entire mold.

GPS-9772 should be applied using a 1:1 plural component equipment capable of producing a minimum delivery rate of 114 gallons per minute at tip pressure of 2000 psi (13.8 MPa) and heating the individual component to 170°F (77°C) using an impigment gun. Hose temperature should be maintained at 135-150°F

(57- 65°C). The GPS-9120material should be preheated to 75-90°F (24-32°C). GPS-9120 should be sprayed in multidirectional passes for a proper uniform thickness.

WARRANTY
